Deposits:

Residential Deposit

One-sixth (1/6) estimated annual billings or not more than one and one-half (1 ½) times the residential customer's estimated maximum monthly bill. (Waived upon receipt of good letter of credit)

Commercial Deposit (<50kVA)

\$150.00 or two and one-half (2 ½) times the commercial consumers' estimated average bill whichever is greater. (Waived upon receipt of good letter of credit)

Commercial Deposit (=>50kVA)

\$10.00/kVA or two and one-half (2 ½) times the commercial consumers' estimated average bill whichever is greater. (Waived upon receipt of good letter of credit)

Interest on deposits shall be made in accordance with the NMRPC Rules and Regulations.
