Energy Efficiency Tip of the Month

This spring, consider using a rain barrel to save energy. Rain barrels capture rainwater from a roof that can be used later for watering your lawn, garden or indoor plants.



CNMEC Avian Protection Program

CNMEC has been involved in working with safeguards with avian protection since 2005. We have invested in over \$150,000.00 just in avian protective devices alone and that doesn't include the labor costs of installation.

Our Operations department and linemen have installed avian protection equipment throughout the CNMEC service territory primarily focusing on areas that we are aware of having nesting or high bird activity. These areas are where irrigation and farming are being done primarily since these areas tend to be watered and wide open with our power lines being the best place birds like to be.

When we find issues concerning bird related injuries or deaths, we will inspect or install new bird guard if necessary. We are also vigilant in watching where bird activity is new or increased. There isn't a guarantee for 100% bird protection equipment, and we do the best we can for the safety of all avian species and other animals. This equipment is not primarily put in place just for birds but also our fur bearing animals as well. In the past, we have constructed nesting perches on new poles we set next to existing power-lines in areas where nesting is high to help control issues.

We have a working relationship with the US Fish & Wildlife agency and proper permitting to relocate or remove nests that may come in harm's way and to rescue or transport or communicate with the proper authorities to move birds that have been injured or killed. In 2004 we were awarded a conservation award from Hawks Aloft for outstanding conservation efforts to protect nesting Ferruginous Hawks. We will continue our efforts to the best of our ability.
